WHERE WE'RE TAKING ACTION: REDUCING CARBON AND TRACKING PRODUCT LIFECYCLES

In Dolphin's environmental management plan outline, we have identified these key areas to monitor, implement improvements, reduce embodied and operational carbon across operations and collect data on the life cycles of our commercial washroom supplies:

I. REDUCE REFRIGERANT EMISSIONS

Minimise refrigerant leaks from office HVAC systems to reduce greenhouse gas emissions.

2. TRACK WORK TRAVEL EMISSIONS

Issue fuel cards for work-related travel to accurately track fuel usage and emissions.

3. MONITOR WASTE AND DISPOSAL METHODS

Monitor waste types and disposal methods to support more sustainable practices.

4. COLLECT LIFECYCLE DATA ON SOLD WASHROOM SUPPLIES

Issue fuel cards for work-related travel to accurately track fuel usage and emissions.

5. MINIMISE EMISSIONS THROUGH SMARTER DISTRIBUTION

Issue fuel cards for work-related travel to accurately track fuel usage and emissions.

6. PRODUCE ENVIRONMENTAL PRODUCT DECLARATIONS EPD

Use automated Life Cycle Assessment software to publish verified EPDs for each commercial washroom product.

7. IMPROVE OXYGEN LEVELS AND BIODIVERSITY

Increase oxygen levels and biodiversity by planting trees and vegetation around Dolphin's premises.

8. CRADLE-TO-GRAVE TRACKING

Monitor product performance through to disposal, including disposal methods.

9. CRADLE-TO-CRADLE STRATEGIES

Recycle or upcycle products into new components, supporting circular design principles.
